Key message	Most cities and regions respond complex emergencies and localize the 2030 Agenda within large governance systems, and in particular, in collaboration with other spheres of government. No sphere of government has the ability to tackle complex crises and achieve the Agenda 2030 on its own.	
Key message	Local and regional governments are too often in a weak position (in terms of competences, resources, legal recognition). Therefore, effective and fair multilevel governance arrangements need adequate approaches and policies. Multilevel governance is the only alternative to respond to the increasing share of responsibilities, territorial fragmentation and

	complex emergencies, and to do so in accordance with the principles of subsidiarity and local autonomy, in the framework of responses to increasing inequalities, worsening climate change and overlapping socio-environmental crises.
Objectives	The session aims to:     - reinforce local democracy and subsidiarity     - rethink the challenges of decentralization     - deal with regional and local inequalities     - strengthen multilevel governance
Main deliverables / impact of the session	Rethink the challenges posed by multilevel governance, mainly in terms of decentralisation, and highlight its importance to achieve more equal, resilient and sustainable territories, and to make these territories able to deal in a flexible and effective way with the transitions we are currently facing (urbanisation, digital transition, energy, ecological challenges) and those that will emerge in the future. The overall aim being to ensure democracy, fulfill human rights and improve the quality of life of citizens and residents. The session aims to provide local and regional governments with practical information, and the appropriate frameworks, knowledge and resources to deal with the new demands for managing responses to complex crises (economic, energy, social, migration, gender, climate change).
